PARTICIPANT RELEASE AND WAIVER OF RIGHTS**

In consideration for the opportunity to **voluntarily participate** for my own personal benefit in the below listed Isles, Inc. activities ("Activity"), I understand that the Activity involves **risks of serious personal injury and death**, as well as loss or damage to property and fully accept and assume all risks, known and unknown, and accept all responsibility for losses, costs, and damages I incur as a result of my participation in the Activity.

I further hereby **release, discharge, and promise and covenant not to sue**, or in any way aid in the institution or prosecution of a suit or claim against, Isles, Inc., and any sponsors, organizers, and site owners or lessees and their affiliates, subsidiaries, administrators, trustees, directors, agents, officers, representatives, volunteers, consultants, contractors, and employees ("Releasees") from all liability, claims, demands, losses, expenses, or damages on my account, including death, disability, or loss or damage to person or property caused or alleged to be caused in whole or in part by the carelessness, negligence, recklessness, or willful misconduct of the Releasees or otherwise, including negligent operations. I further agree that if, despite this release and waiver of liability, assumption of risk, and indemnity agreement, I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save and hold harmless each of the Releasees, from any litigation expenses, claims, demands, attorney fees, loss, liability, expense, damage, or cost which any Releasee may incur as a result of such claim. I agree that this Release and Waiver will be governed by the laws of New Jersey.
