We seek an experienced, community-focused colleague to support and manage FAS staff, collaborate with partners throughout the region, and leverage Isles' FAS services as a strategy for equitable and anti-racist community and economic development. The successful candidate will embrace the wide range of services and responsibilities of a well-established and multifaceted service area, including grant writing, management, and implementation, direct service provision, and building and growing relationships with partners, funders, and public officials. Working closely with the Managing Director of Community Services, they will have the opportunity to build on four decades of food and sustainability work in the Trenton region and contribute to the economic vitality and environmental health of the region in a leadership role at one of the region's most innovative and successful nonprofits.

FAS Leadership

With Isles leadership, the FAS Deputy Director will provide direction and vision for FAS growth and development and support the 4 FAS dedicated staff members in meeting its goals. The Deputy Director will establish and sustain a supportive, creative, and fun work environment, while ensuring effective program and project management and implementation, and aligning program goals and objectives with grant requirements and staff activities. The Deputy Director will coordinate with Planning & Placemaking staff and the Managing Director to ensure coordination and collaboration across Isles service areas, and will represent Isles, Community Planning & Development, and FAS in public settings to advance the goals and service implementation of FAS.

Project Management and Implementation

The FAS Deputy Director is responsible for the successful design, implementation, and management of FAS projects, programs, and services, specifically Urban Agriculture, Trenton Climate Corps, and Community Food Initiatives. The Deputy Director provides hands-on support to staff in developing and implementing programs and events and applies their experience and expertise to ensure quality project implementation.

Administration and Management

Working with the Managing Director and Isles administration, the Deputy Director will manage departmental budgets and expenses, ensuring appropriate spending and management of funds. The Deputy Director will manage existing grants and identify and secure new sources of funding to advance the goals of Isles FAS and related services. The Deputy Director will develop and sustain effective management systems and workflows to efficiently document and implement processes related to FAS activities and services.
